## CHE 352

This course provides the synthetic organic chemistry laboratory experience needed for chemistry and science majors, and pre-professional majors in medicine, dentistry, pharmacy, and chiropractics. This accelerated schedule includes 80 hours of instruction/lab over a two-week period.

The primary goal is to provide a lab experience for those students who are taking organic chemistry lecture at small campuses via distance education, but who do not have access to laboratory instruction. The course will also serve other UWC and UW System students who have been unable to complete organic labs.
